Major Violations

Rubber seal/gasket on the left door of the 2 door prep unit observed in disrepair. [Corrective Action] Repair or replace the rubber seal/gasket.

K36 - 2 Points - Equipment, utensils, linens: Improper storage and use; 114074, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.3, 114185.4, 114185.5

Inspector Observations:

The handle of the ice scoop observe touching the ice in the ice bin at the service area. [Corrective Action] Store the ice scoop in such a way that the handle does not touch the ice.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations:

Grime accumulation in the floor sink at the service area. [Corrective Action] Routinely clean.

K47 - 2 Points - Signs not posted; last inspection report not available; 113725.1, 113953.5, 113978, 114381(e)

Inspector Observations:

The health permit was not observed posted in public view. [Corrective Action] Post the current health permit in public view.
