## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K30 - 2 Points - Food storage containers are not identified; 114047, 114049, 114051, 114053, 114055, 114067(h), 114069 (b)

**Inspector Observations: Observed bulk food containers of nuts not labeled. [CA] Label the containers with the contents. [COS] The containers were labeled.**

K36 - 2 Points - Equipment, utensils, linens: Improper storage and use; 114074, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.3, 114185.4, 114185.5

**Inspector Observations: Observed plastic basket like containers used as direct food contact containers holding hot chicken. [CA] The food containers must be approved food containers. Discontinue using those baskets for food contact storage.**

K38 - 2 Points - Inadequate ventilation and lighting in designated area; 114149, 114149.1, 114149.2, 114149.3, 114252, 114252.1

**Inspector Observations: Observed a couple of light bulbs out in the cook line. [CA] Replace the light bulbs that are not working.**

K40 - 2 Points - Wiping cloths: improperly used and stored; 114135, 114185.1 114185.3(d,e)

**Inspector Observations: Observed used wiping towels on table tops in the kitchen. [CA] Keep the used wiping towels in a sanitizer container between each use. [COS] The towels were placed in a bucket with sanitizer.**
