Second Follow up inspection after facility closure on 1/8/2024 due to vermin infestation.

The following violation was corrected : k23 - No rodents, insects, birds or animals

- *One mid size cockroach found inside paper towel dispenser next to the preparation sink. Owner immediately removed it and cleaned and sanitized inside the dispenser and all areas around.*
- *No other live activity observed.*
- *Facility sealed the gap in the left back hallway door.*
- *Facility was serviced on 1/9/2024 and pest report was provided for review.*
- *Continue to seal any remaining gaps and crevices.*
- *Continue to clean and sanitize areas of dead cockroaches.*
- *Facility is Ok to reopen.*

Subsequent follow-up inspection after first follow-up shall be billed \$290/hour, minimum one hour, during normal business hours (Monday - Friday, 7:30 AM to 4:30 PM), and \$629/hour, minimum two hours, during non-business hours, and upon inspector availability.

FACILITY RE-OPENED / PERMIT REINSTATED

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made.
