Major Violations

Inspector Observations: Some food handler cards for employees have expired this year.
[CA] Each food handler shall maintain a valid food handler card for the duration of his or her employment as food handler. A valid food handler card shall be provided within 30 days of after the date of hire.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: Hole noted on the pipping for the water heater in the back of facility.
[CA] Repair holes in structure and maintain in good repair to prevent pest harborage.
