Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations: *There is no hand wash sink in the facility. Food is prepared here and there is only a dish sink. A hand sink and food prep sink are the current requirements. At this time a hand sink will be needed and if any remodel is done the food prep sink will also be needed at that time. [CA] Install a hand sink. Seems there is already a connection for a hand sink from the past.*

K21 - 3 Points - Hot and cold water not available; 113953(c), 114099.2(b), 114163(a), 114189, 114192, 114192.1, 11419

Inspector Observations: *The hot water reaches 110 degrees F at the dish sink. [CA] The temperature must reach 120 degrees F. [COS] The temperature reached 120 by end of inspections after the employee adjusted the water heater.*
