Inspector Observations: FOUND THE VITAMIX MIXING MACHINE WITHIN CLOSE PROXIMITY WITH THE FOOD PREPARATION TABLES IN THE FRONT SERVICE AREA. [CA] PROVIDE A MINIMUM 6" HIGH METAL SPLASH GUARD SPANNING THE FULL LENGTH OF THE SINK. OR REMOVE THE MACHINE.
