### Major Violations

**Inspector Observations: Build up of dust and grease debris on the mechanical exhaust hood.**

**[CA] Clean mechanical exhaust hood and/or filters of grease accumulation.**

K44 - 2 Points - Premises not clean, not in good repair; No personal/chemical storage; inadequate vermin-proofing; 114067(j), 114123, 114143 (a,b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282

**Inspector Observations: Dry storage area with freezers has unnecessary items on shelving and floor.**

**[CA] The premises of a food facility shall be free of litter and items that are unnecessary to the operation or maintenance of the facility, such as equipment that is nonfunctional or no longer used.**

**Inspector Observations: Build up of grease debris on wall behind the cook line.**

**[CA] Clean walls more frequently to prevent build ups.**
