Major Violations

No major violations were observed during this inspection.

Minor Violations

K30 - 2 Points - Food storage containers are not identified; 114047, 114049, 114051, 114053, 114055, 114067(h), 114069 (b)

Inspector Observations: Boxes of bulk dry food product stored on the floor of the kitchen.

[CA] Food and food contact items shall be stored at least 6 inches above the floor to prevent contamination.

K43 - 2 Points - Toilet facilities: improperly constructed, supplied, cleaned; 114250, 114250.1, 114276

Inspector Observations: No toilet paper at the employee restroom toilet.

[CA] Toilet tissue shall be provided in a permanently installed dispenser at each toilet.

[COS] Toilet paper provided.
