Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

Inspector Observations: The Food Safety Certificate (FSC) has expired.[CA]Food facilities that prepare, handle, or serve non-prepackaged potentially hazard foods shall have a valid Food Safety Certificate available for review at all times. Facility shall have 60 days to obtain a valid FSC.

Inspector Observations: Black mold like substances found on the inside panel of the ice machine.[CA]Clean and sanitize the inside panel of the ice machine.

Inspector Observations: Observed a sugar cane machine that is not ANSI certified (NSF, ETL or UL sanitation). [CA] All food equipment must be ANSI certified.
