Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K34 - 2 Points - Warewashing facilities: not installed or maintained; no test strips; 114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125

Inspector Observations: Observed the quat sanitizer tested at about 0ppm in the dish sink. [CA] The dish sink must be kept at 200ppm quat.

K35 - 2 Points - Equipment, utensils - Unapproved, unclean, not in good repair, inadequate capacity; 114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114175, 114177, 114180, 114182

Inspector Observations: Observed the table below the monitor to have encrusted food accumulation on the edges. [CA] Thoroughly clean the table.

K38 - 2 Points - Inadequate ventilation and lighting in designated area; 114149, 114149.1, 114149.2, 114149.3, 114252, 114252.1

Inspector Observations: Observed the light in the walk in to not have a cover and not be shatterproof. [CA] Provide the cover or a shatterproof lighbulb.

K40 - 2 Points - Wiping cloths: improperly used and stored; 114135, 114185.1 114185.3(d,e)

Inspector Observations: Observed the towel bucket near the chicken frying area to have 0 ppm quat. [CA] The towels must be kept in 200ppm quat. [CA] The sanitizer level was corrected.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: Observed the floor to have accumulation in the corners in most all areas. [CA] Thoroughly clean the floors.
