*- K22: Sewage and wastewater properly disposed. All sewage is flowing down floor sinks properly. Tested mop sink, floor sink next to 3-compartment, and hand wash stations. All sinks are working well.*

*- Facility is allowed to re-open.*

*Continue working on all other violations mentioned on 9/9/25 inspection report.*
