Major Violations

Inspector Observations: Found a few flies in middle aisle where containers are stored in rack and locker area.
[CA] Each food facility shall be free of pest such as flies. Provide approved pest control services.

K41 - 2 Points - Plumbing unapproved, not installed, not in good repair; improper backflow devices; 114171, 114189.1, 114190, 114192, 114193, 114193.1, 114199, 114201, 114269

Inspector Observations: Found leaks at the following sinks: 2-compartment sink, 1 compartment sink and mop sink when water is turned on in middle section). [CA] Repair leak.
