Comments and Observations

Major Violations

K06 - 8 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations:

Lack of paper towels at the handwash sink in the men's restroom.

[Corrective Action] Ensure paper towels are available at all time to be able to properly dry hands.

[Corrected on Site] Person in charged refilled the paper towel dispenser.

Minor Violations

K14 - 3 Points - Food contact surfaces unclean and unsanitized; 113984(e), 114097, 114099.1, 114099.4, 114099.6, 114101, 114105, 114109, 114111, 114113, 114115(a,b,d), 114117, 14125(b), 114141

Inspector Observations:

Chlorine sanitizer in the dishwasher was measured at 0 ppm. No active warewashing at the time of inspection.

[Corrective Action] Maintain chlorine sanitizer at 50 ppm in the dishwasher. Sanitize utensils in the 3 compartment sink with 100 ppm chlorine sanitizer until dishwasher is repaired.

K38 - 2 Points - Inadequate ventilation and lighting in designated area; 114149, 114149.1, 114149.2, 114149.3, 114252, 114252.1

Inspector Observations:

The dual stock pot burner was observed not completely under the exhaust hood.

[Corrective Action] Ensure cooking equipments are completely under the exhaust hood with at least 6 inches overhang.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations:

Observed the floor grout become thin at the warewash area.

[Corrective Action] Maintain floors in good condition.
