## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K27 - 2 Points - Food not separated and unprotected; 113984(a-d,f), 113986, 114060, 114067(a,d,e,j), 114069(a,b), 114077, 114089.1(c), 114143(c)

**Inspector Observations: Found some food products outdoors, such as flour.**

**[CA] - Relocate all foods within the enclosed facility. Do not store or prepare any foods outdoors.**

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

**Inspector Observations: 1. Ceiling in rear room is unfinished wood.**

**2. Several floor tiles in back area are missing and/or broken**

**3. Found food splatter stains on wall near chicken dredging area.**

**[CA]- Ensure all floors, walls and ceilings are smooth, durable and easily cleanable. Clean all floors, walls and ceilings thoroughly and regularly.**
