An SOP has been created by the facility for utilizing the reduced oxygen packaging for 48 hours or less.

The impound has been lifted on the VacMaster machine for use only for the items and processes outlined in the SOP.

The charcoal grills have been relocated for use under the dedicated ventilation hood.

Continue to work on relocating chest freezer into the facility or removing from the premises. Email inspector an imagine of the relocated or removed unit.

When required to determine compliance, a single reinspection will be conducted without additional charge.
