Major Violations

No major violations were observed during this inspection.

Minor Violations

K14 - 3 Points - Food contact surfaces unclean and unsanitized; 113984(e), 114097, 114099.1, 114099.4, 114099.6, 114101, 114105, 114109, 114111, 114113, 114115(a,b,d), 114117, 14125(b), 114141

Inspector Observations: FOUND THE CHLORINE SANITIZER AT THE 3 COMPARTMENT SINK AT 200PPM. [CA] PROVIDE 100 PPM SANITIZER LEVEL.

K21 - 3 Points - Hot and cold water not available; 113953(c), 114099.2(b), 114163(a), 114189, 114192, 114192.1, 11419

Inspector Observations: THE HAND WASH SINK IS NOT DISPENSING HOT WATER. [CA] ENSURE THAT THE HOT WATER IS AVAILABLE AT 100F MINIMUM FOR HAND WASHING.

K32 - 2 Points - Food improperly labeled & not honestly presented: 114087, 114089, 114089.1(a, b), 114090, 114093.1

Inspector Observations: FOUND THE ICE MACHINE WITH CALCIUM DEPOSITS ON THE SIDE AND TOP OF THE MACHINE. [CA] CLEAN THE MACHINE MORE OFTEN.
