## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

**Inspector Observations: Hand wash station within the bar is missing soap and paper towels at the time of inspection.**

**[CA] Hand wash stations must be fully stocked and operational at all times.**

**[COS] Hand wash was stocked.**

K14 - 3 Points - Food contact surfaces unclean and unsanitized; 113984(e), 114097, 114099.1, 114099.4, 114099.6, 114101, 114105, 114109, 114111, 114113, 114115(a,b,d), 114117, 14125(b), 114141

**Inspector Observations: Mold like substance growing on the interior panel of ice machine.**

**[CA] Clean/sanitize ice machine per manufactures specifications.**
