Inspector Observations: Cockroach activity observed in the following areas:

- 5+ live cockroaches observed inside crevices of the storage rack with wooden top platform across from the walk-in refrigerator.

- 5+ live cockroaches observed on the underside of the lip converging the four-compartment sink and long preparation table with food preparation sink at the end.

- Numerous dying cockroaches observed inside sloped drain under the cook line.
- Dying cockroach observed on floor between storage rack and laundry machine.
- 2 egg sacs observed on floor underneath the four-compartment sink.
- 1 egg sac observed inside crevice of the meat slicer.
- Dead cockroaches observed in the following areas:
  - Inside the janitorial sink.
  - On floor by the side door of the facility.
  - On floor underneath the four-compartment sink.
  - On the unused island preparation table.

Facility was serviced by pest control on 8/11/2022.

Facility is to remain closed until vermin infestation is completely abated.

[CA] The premises of each food facility shall be kept free of vermin. ### **Overall Comments:**

- On-site for follow-up inspection after facility was closed due to vermin during a routine inspection on 8/11/2022.

- Facility is to remain closed until vermin infestation is completely abated.
- Subsequent follow-up inspection shall be billed at \$219/hour during normal business hour, Monday Friday 7:30 AM to 5:00 PM,
- or \$493/hour during non-business hours, and upon inspector availability.

- The posted placard is property of the Santa Clara County Department of Environmental Health and shall not be removed, covered-up, relocated, tampered, or copied red placard. Failure to comply may result in enforcement actions per County Ordinance Code Section B11-55.

## **CLOSURE / PERMIT SUSPENSION NOTICE**

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Unless otherwise noted by the inspector, all violations are to be corrected no later than <u>8/26/2022</u>. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.

This notice is to inform you that as of this date the Environmental Health Permit for the above mentioned food facility is hereby suspended and all operations therewith are ordered to cease. This action is taken in accordance with Section 114409 of the California Health and Safety Code which states 'If any imminent health hazard is found, unless the hazard is immediately corrected, an enforcement officer may temporarily suspend the permit and order the food facility or cottage food operation immediately closed.'

You have the right to make a written request for a hearing within 15 days after receipt of this notice to show just cause why the permit suspension is not warranted. Failure to request such a hearing within the 15-day period shall be deemed a waiver of the right to a hearing.
