Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

Inspector Observations: The FSC is expired. [CA] Obtain a current FSC.

K23 - 3 Points - Observed rodents, insects, birds, or animals; 114259.1, 114259.4, 114259.5

Inspector Observations: Customer had her pet dog in the facility. Owner stated that he was unaware that pets were not allowed in the facility [CA]. Pets are not allowed in the facility. [COS] The owner asked her to go outside with her pet.

K34 - 2 Points - Warewashing facilities: not installed or maintained; no test strips; 114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125

Inspector Observations: The warewashing sink had 100ppm quat or less. [CA] The concentration must be kept at 200ppm quat.
