Overall Comments:

Follow-up for routine inspection conducted on 4/25/24 regarding water heater.

Water heater was changed to one that is of a smaller capacity and is unable to maintain hot water for in the facility at 120F. Hot water shall be supplied at a minimum temperature of at least 120°F measured from the faucet throughout facility except at handwash sinks.

At time of inspection, hot water was ran simultaneously from the three compartment sink and prep sink with temperatures initially measured at 126F but dropped to 86F in under a minute.

The addition of new equipment will be required to be submitted to this department's Plan Check for review and approval prior to installation EXCEPT when equipment is replaced like-for-like (same model and capacity as previously approved water heater).

A subsequent follow-up inspection will be required and scheduled for 5/21/24.

Subsequent follow up inspection after first follow up shall be billed \$290/hr during business hours and \$629/hrs (minimum of 2 hours) during nonbusiness hours upon availability.

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Unless otherwise noted by the inspector, all violations are to be corrected no later than <u>5/21/2024</u>. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.
