The permit will be revoked if the permit application is not received within 48hrs. Okay to Operate.

An official permit will be mailed to the address on file and shall be posted in public view upon receipt.

Currently, the owner is required to submit plans by 11/3/23 to include any changes in the layout and new equipment addition as advised per email sent on 10/25/23, a 25% late fee will be assessed.
