Inspector Observations: Hot water at three compartment sink measured 77F after allowing water to run, water temperature did not fluctuate when allowing it to run. [CA] Hot water shall be supplied at a minimum temperature of at least 120°F measured from the faucet throughout facility except at handwash sinks.

## **CLOSURE / PERMIT SUSPENSION NOTICE**
