Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K33 - 2 Points - Nonfood contact surfaces not clean; 114115(c)

Inspector Observations: Floor sink located under the soda machine has accumulation of black mold-like substance. [CA] Frequently clean nonfood contact surfaces to prevent accumulation of mold or other debris.

K35 - 2 Points - Equipment, utensils - Unapproved, unclean, not in good repair, inadequate capacity; 114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114175, 114177, 114180, 114182

Inspector Observations: Gasket on upright reach-in cooler by the deep fryers is in disrepair. [CA] Replace damaged gaskets and maintain in good repair.

Inspector Observations: Employee's personal drink is stored above food inside upright reach-in cooler by the deep fryers. [CA] Employee's personal beverages shall be stored separate or below food served in the facility.
