Major Violations

No major violations were observed during this inspection.

Minor Violations

Inspector Observations: HOT RUNNING WATER AT THE THREE COMPARTMENT SINK WAS MEASURED 116F.

[CA] Hot water shall be supplied at a minimum temperature of at least 120°F measured from the faucet throughout facility except at hand wash sinks.

Inspector Observations: VENTILATION HOOD FILTERS WERE OUT FOR CLEANING AND OVEN WAS ON.

[CA] Ventilation hood filters shall be maintained clean and put back before using the oven.

Inspector Observations: JANITORIAL SINK LACK HOT WATER CONNECTION. IT WAS TURNED OFF.

[CA] Janitorial sink shall supply hot running water at minimum 120F.

K43 - 2 Points - Toilet facilities: improperly constructed, supplied, cleaned; 114250, 114250.1, 114276

Inspector Observations: TOILET PAPERS WERE ON FLOOR INSIDE THE RESTROOM.

[CA] Toilet facilities shall be maintained clean and in good repair.
