## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K23 - 3 Points - Observed rodents, insects, birds, or animals; 114259.1, 114259.4, 114259.5

**Inspector Observations: Several live gnats found in the kitchen.**

**[CA] Food facility shall be kept free of non-disease carrying insects, weevils, ants, gnats, and fruit flies.**

K38 - 2 Points - Inadequate ventilation and lighting in designated area; 114149, 114149.1, 114149.2, 114149.3, 114252, 114252.1

**Inspector Observations: Heavy buildup found on exhaust filters.**

**[CA] Clean mechanical exhaust hood and/or filters of grease accumulation.**

K39 - 2 Points - Thermometers missing or inaccurate; 114157, 114159

**Inspector Observations: Lack of thermometers in most refrigerator units.**

**[CA] A thermometer +/- 2°F shall be provided and correctly located in each hot and cold holding unit containing potentially hazardous foods.**

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

**Inspector Observations: Moderate amount of food debris and grease buildup on floor under equipment.[CA]**

**Regularly clean under cooking equipment to prevent accumulation of debris.**

**Paint is peeling at wall near rice cookers.**

**[CA] Repair the wall with a durable, smooth, nonabsorbent, and easily cleanable surface.**
