Major Violations

Inspector Observations:

1. Observed paint on the wall at the 3 compartment sink in disrepair.

[Corrective Action] Maintain wall in good condition.

2. Observed black grime on the wall next to the dishwasher.

[Corrective Action] Maintain wall clean.

3. Observed paint on the walk-in freezer door in disrepair.

[Corrective Action] Maintain paint on the door in good condition.
