Inspector Observations: Observed rodent droppings in the front corner on the floor. [CA] Thoroughly clean up the floor and provide rodent stations to help monitor for rodents. According to the manager they are old and no rodent issue exists. Take effective measures to eliminate any rodents from inside the facility and protect food from contamination.

Inspector Observations: Observed accumulation on the floor of the walk in refrigerator. [CA] Thoroughly clean up the floors in the walk in refrigerator.

Inspector Observations: The side door has a gap in it where insects can enter. [CA] Take effective measures to eliminate insects and rodents from entering the facility. Close the gap under the door.

Inspector Observations: Observed debris and accumulation under shelves. [CA] Thoroughly clean up under all shelves and equipment.
