**Inspector Observations: Observed raw salmon above containers of sauce in walk in cooler. [CA] Store raw seafood below sauce/ready to eat food.**

**Inspector Observations: Observed bulk containers of ginger and soy sauce on floor. [CA] Store food 6 inches off of floor.**

K35 - 2 Points - Equipment, utensils - Unapproved, unclean, not in good repair, inadequate capacity; 114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114175, 114177, 114180, 114182

**Inspector Observations: Observed unapproved induction hot plate used to fry eggs and saute shrimp with sauce. Observed turbo chef oven and fryer unit[CA] Discontinue use of equipment and remove from the facility. Recommend to cook egg in microwave instead.**
