PIC provided pest control invoice from terminex dated 8/12/23. Per PIC, facility will continue to get weekly pest control service for a month and then will proceed with monthly pest control service.

Informed PIC to regularly clean under equipment to prevent accumulation of debris. Seal any holes/cracks/crevices to prevent harborage of vermin. Continue with pest control service. Clean & sanitize area of dead cockroaches. Consider submitting plans to Santa Clara County plan check department to update flooring in kitchen.

Facility ok to reopen.

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made.
