## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

**Inspector Observations: One of the two employees preparing the food does not have a food handler or FSC. [CA] Everyone who prepares food is to have a FSC or Food handler card.**

K07 - 3 Points - Improper hot and cold holding temperatures; 11387.1, 113996, 113998, 114037, 114343(a)

**Inspector Observations: Observed containers of cut green onion at room temperature for lunch prep next to the stove. [CA] The cut green onion and other cut up PHF produce next to it is to be time coded or on ice to be held at 41 degrees F. [COS] The restaurant just began setting up and will use the timer and discard at 4 hours.**

K21 - 3 Points - Hot and cold water not available; 113953(c), 114099.2(b), 114163(a), 114189, 114192, 114192.1, 11419

**Inspector Observations: The water at the dish sink reaches 115 degrees F. [CA] Increase the hot water temperature to reach 120 F at the dish sink.**

K40 - 2 Points - Wiping cloths: improperly used and stored; 114135, 114185.1 114185.3(d,e)

**Inspector Observations: Observed the wiping towels in 10-50 ppm chlorine. [CA] The chlorine is to be at 100ppm in the towel bucket.**
