Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K07 - 3 Points - Improper hot and cold holding temperatures; 11387.1, 113996, 113998, 114037, 114343(a)

Inspector Observations: Measured chicken and milk at 44 F within the two door upright refrigerator. Ambient temperature measured at 45 F.

[CA] PHFs shall be held at 41°F or below or at 135°F or above.

[COS] Temperature of the unit decreased. Ambient temperature of the unit decreased to 36 F.

K34 - 2 Points - Warewashing facilities: not installed or maintained; no test strips; 114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125

Inspector Observations: Quat sanitizer test strips not available for measuring the quat sanitizer concentration at the three compartment sink during manual warewashing.

[CA] Testing equipment and materials shall be provided to adequately measure the applicable sanitization method used during manual or mechanical warewashing.

K38 - 2 Points - Inadequate ventilation and lighting in designated area; 114149, 114149.1, 114149.2, 114149.3, 114252, 114252.1

Inspector Observations: Multiple lights within the mens restroom are non-functional.

[CA] In every room sufficient natural or artificial lighting shall be provided. Repair or replace light bulbs.


