Note: This is a follow-up inspection to the routine inspection that was conducted 08/28/2026. The facility was issued a conditional pass due to the failure of employees to wash hand whenever its needed and for storing food out of safe temperature zone. The sauce is being stored at room temperature using time as a public health control method.

During today's follow-up inspection, both violations were observed to be corrected. Therefore, the facility is issued a pass green placard.

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Unless otherwise noted by the inspector, all violations are to be corrected no later than **9/16/2026**. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.
