### Major Violations

K15 - 8 Points - Food not obtained from approved source; 113980, 113982, 114021-114031, 114041

**Inspector Observations: 7 one pint containers of chutney being sold without labeling [CA] Remove items from sale and only sell items from approved sources. – Containers were removed during the inspection**

### Minor Violations

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

**Inspector Observations: Restroom paper towel dispenser is not working, Employee said it was out of battery. A roll of paper towel is on top of the dispenser [CA] Keep all dispensers in working condition**
