Major Violations

Inspector Observations: Observed the glue trap to be filled with roaches. [CA] Discard this and replace with new traps. Take effective measures to eliminate roaches from inside the facility. Be sure to protect food from possible contamination.

Inspector Observations: The back door is left open. [CA] Keep the door closed or provide a screen door or an air curtain.

According to the employee there are only enough ice blocks for the salad bar only. Please obtain more ice blocks for any potentially hazardous items that are being served.
