**Inspector Observations: Observed a container with broth stored directly on floor.**

**[CA] Food shall be stored at least 6 inches above the floor to prevent contamination.**

**Inspector Observations: Observed a bowl used to scoop cooked rice in warmer.**

**[CA] Use a scoop with a handle and store scoop handle in such a way that the handle does not come in direct contact with food to prevent contamination.**
