Inspector Observations: Dishwasher sanitizer at 25 ppm [CA] Monitor and maintain sanitizer level at 50 ppm [SA] Sanitize items in 200 ppm quat sanitizer in the three-compartment sink until the dishwasher has been modified to provide 50 ppm chlorine residual.
