**Inspector Observations: Dispenser for hand washing cleanser at the restroom is empty.**

**[CA] Handwashing cleanser shall be provided in dispensers; heated-air hand drying device may be substituted for single-use sanitary towels.**

**[COS] Employee refilled hand washing cleanser dispenser.**
