### Major Violations

**Inspector Observations: Observed prepackaged containers of seeds lacked labels.**

**[CA] Food prepackaged in a food facility shall bear a label that includes:**

1. **The common name of the food.**
2. **If made from two or more ingredients, a list of ingredients in order of weight.**
3. **Quantity of the contents.**
4. **Name and place of business of the manufacturer, packer, or distributor.**
