Inspector Observations: Handwash sink in the kitchen was obstructed by equipment stored in the basin of the sink. [CA] Handwash sink shall be kept unobstructed and easily accessible to allow for proper handwashing as required.

K23 - 3 Points - Observed rodents, insects, birds, or animals; 114259.1, 114259.4, 114259.5

Inspector Observations: Flies observed in the kitchen and food storage area. [CA] Facility shall be kept free of flies.
