**Inspector Observations: Hand wash station next to the prep sink is missing a paper towel dispenser at the time of inspection.**

**[CA] Install a new paper towel dispenser next to the hand wash station.**

**Inspector Observations: Equipment in the back of the facility is no longer in use.**
