# **Overall Comments:**

This is a follow up inspection to verify that all major violations mentioned on 6/26/23 inspection report have been addressed. Only one major violation was addressed and other violations are not found within compliance:

- K06: Adequate hand wash facilities supplied, accessible. Hand wash station next to cashier station is fully accessible and stocked at the time of inspection.
- K23: No rodents, insects, birds, or animals. Evidence of multiple dead cockroaches around the food facility and live one within the dinning room area.

The facility is to remain closed until vermin activity has been abated. Contact our department for a follow up inspection (408)918-3400.

# **CLOSURE / PERMIT SUSPENSION NOTICE**

When required to determine compliance, a single reinspection will be conducted without additional charge. This notice is to inform you that as of this date the Environmental Health Permit for the above mentioned food facility is hereby suspended and all operations therewith are ordered to cease. This action is taken in accordance with Section 114409 of the California Health and Safety Code which states 'If any imminent health hazard is found, unless the hazard is immediately corrected, an enforcement officer may temporarily suspend the permit and order the food facility or cottage food operation immediately closed.'

You have the right to make a written request for a hearing within 15 days after receipt of this notice to show just cause why the permit suspension is not warranted. Failure to request such a hearing within the 15-day period shall be deemed a waiver of the right to a hearing.
