Inspector Observations: cheese in prep table cooler at 65F, no other perishable items noted in the unit. operator stated that each cheese batch in the unit is used less than an hour. prawn and brine in advised operators to use ice bath until serviced.

prawn and brine in 2 door worktop cooler at 45F
