Inspector Observations: LACK OF SOAP AND PAPER TOWELS AT KITCHEN HANDWASH SINK. PAPER TOWELS ARE OUTSIDE OF DISPENSER AT RESTROOM PAPER TOWEL DISPENSER. [CA] ENSURE PAPER TOWELS AND SOAP ARE AVAILABLE INSIDE DISPENSERS AT ALL TIMES TO FACILITATE PROPER HAND WASHING. [COS] DISPENSERS RE-FILLED.
