Comments and Observations

Major Violations

K08 - 8 Points - Improperly using time as a public health control procedures & records; 114000

Inspector Observations: *At the front counter, measured pepperoni pizza at 98F. Per operator, pizza is stored for no more than 4 hours from 12:00pm to 4:00pm. Time log was not filled out.*

[CA] *Potentially hazardous foods maintained by time shall be time labeled/time marked when removed from temperature control and served within 4 hours or discard.*

[SA] *Operator to serve pepperoni pizza by 4:00pm or discard for a total of 4 hours from when removed from temperature control.*

Minor Violations

K23 - 3 Points - Observed rodents, insects, birds, or animals; 114259.1, 114259.4, 114259.5

Inspector Observations: *In the warewash area, observed fruit flies.*

[CA] *Ensure facility is kept free of fruit flies to prevent possible contamination of food.*
