Comments and Observations

Major Violations

K07 - 8 Points - Improper hot and cold holding temperatures; 11387.1, 113996, 113998, 114037, 114343(a)

Inspector Observations: Various PHF held in drawer refrigerator measured >41F,<135F,<1hr.

[CA] PHFs shall be held at 41°F or below or at 135°F or above. [COS] Per PIC, PHF was held in drawer refrigerator for less than 1 hour. Refrigerator appear to be unplugged. PHF moved to standing refrigerator for rapid cooling. Drawer refrigerator plugged in.

Minor Violations

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

Inspector Observations: FSC is not available for review at time of inspection.[CA]

Food facilities that prepare, handle, or serve non-prepackaged potentially hazard foods shall have a valid Food Safety Certificate available for review at all times.

K27 - 2 Points - Food not separated and unprotected; 113984(a-d,f), 113986, 114060, 114067(a,d,e,j), 114069(a,b), 114077, 114089.1(c), 114143(c)

Inspector Observations: Equipment/food placed at drip line at hand wash sink.

[CA] All food shall be separated and protected from possible contamination.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: Portion of the wall at cook line is damaged.

[CA] Repair holes in structure and maintain in good repair to prevent pest harborage.
