Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K34 - 2 Points - Warewashing facilities: not installed or maintained; no test strips; 114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125

Inspector Observations: At the end of the inspection the manager was informed that the test strips they have on hand are the wrong strips. The sanitizer being used is lactic acid based and the test strips are for quat. [CA] Provide the correct strips.

The dish washing sink faucet is leaking water and has black tape around it. [CA] Replace or repair the faucet.

K35 - 2 Points - Equipment, utensils - Unapproved, unclean, not in good repair, inadequate capacity; 114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114175, 114177, 114180, 114182

Inspector Observations: Observed the containers for clean utensils to have food particles and small debris in them. [CA] Wash and sanitize the bins that are used for clean utensils.

K39 - 2 Points - Thermometers missing or inaccurate; 114157, 114159

Inspector Observations: Thermometer not in two of the refrigerators. [CA] Provide a thermometer in each unit to monitor proper temperature.
