#### **Overall Comments:**

Note: 1. This is a follow-up inspection to the limited inspection conducted yesterday. The facility was closed due to the lack of water supply. During the time if this inspection, all sinks in the facility have both cold and 120 OF warm water. Therefore, the facility is open for service.

The following violations must be corrected ASAP as well:

Gas cylinders in the bar must be kept restrained to a secure stand

The men's restroom has a foul smell. Investigate if the exhaust fan system is working, and clean the screen cover immediately. No paper towel was observed in the handwash sink of the kitchen. Refill the paper towel dispenser immediately There is no splash guard separating the handwash sink from the ice container in the bar area.

2. According to the person in charge, one of the owners of the corporation passed away, and only two of the three partners are owning the business now. The person in charge is told to submit documents submitted to the State Secretary Office that indicate the current owners were owners of the previous corporation to Mamaye.Kebede@cep.sccgov.org within the next 48 working hours.

3. Since this is an owner initiated follow-up inspection on the weekend, the corporation will be billed \$493.00. The invoice must be paid within ten days of receiving it.

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Unless otherwise noted by the inspector, all violations are to be corrected no later than <u>5/14/2022</u>. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.
