Major Violations

No major violations were observed during this inspection.

Minor Violations

K33 - 2 Points - Nonfood contact surfaces not clean; 114115(c)

Inspector Observations: Observed the area where the bread is kept to have debris on the back areas. [CA] thoroughly clean the area where the bread is kept.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: The floors are missing grout in several areas which is causing food particles and mold-mildew like accumulation. [CA] Repair the floors where needed.
