**Inspector Observations: Facility is brewing coffee for customers and uses multi use equipment. Facility does not have a three compartment sink or hand wash sink for proper warewashing. Facility is only approved for no food prep health permit. Discontinue serving coffee.**

**[CA] Discontinue conducting any food prep If the facility plans to build or remodel a food facility shall submit plans and specifications for review and shall receive plan approval prior to starting any new construction or remodeling.
