**SECOND FOLLOW UP INSPECTION FROM 9/6/23.**

**THE FACILITY WAS INITIALLY CLOSED DUE TO HAVING NO ELECTRICITY AND THEY WERE PREPARING FOOD.**

**AFTER THE ELECTRICITY WAS RE-ESTABLISHED ON 9/6/23, THE OWNER REQUESTED A FOLLOW UP INSPECTION ON THE SAME DAY.**

**DURING THE FIRST RE-INSPECTION, THE HOT WATER WAS LACKING AT THE FACILITY AND THE FACILITY REMAINED CLOSED.**

**FINDINGS ON THE SECOND RE-INSPECTION: THE HOT WATER IS AT 120F AT THE 3 COMPARTMENT SINK AND THE FOOD PREPARATION SINK. THE HAND WASH SINK IS ABOVE 100F.**

**OK TO RE-OPEN.**

**THIS RE-INSPECTION WILL BE CHARGED AT \$290 AN HOUR, MINIMUM ONE HOUR. AN OFFICE HEARING APPOINTMENT WILL BE REQUIRED. A LETTER WILL BE MAILED WITH THE DETAILS.**

### **FACILITY RE-OPENED / PERMIT REINSTATED**

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Unless otherwise noted by the inspector, all violations are to be corrected no later than **9/21/2023**. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.
